Circle Line Photography Competition 2010 (the “Competition”)

Terms & Conditions

- ▶▶ The Competition is organised and promoted by LTA, 1 Hampshire Road Singapore 219428 (“LTA”). All participants to this competition shall be subjected to these Terms stipulated by LTA. By participating in this Competition, participants shall be deemed to have understood and agreed to these Terms.
- ▶▶ LTA reserves the right to change the Terms and dates of this Competition at its sole discretion. All changes will be duly publicised. By participating in this Competition, participants are taken to have agreed to the changes that may be made from time to time.
- ▶▶ The Competition shall be open from 17 February 2010 to 17 March 2010. This Competition is open to all citizens and residents of Singapore. Employees of LTA, its subsidiaries, public relations and advertising agencies, and the immediate families of these parties are not eligible to participate in the Competition. LTA reserves the right to disqualify any such person and require the reimbursement of the value of any prizes awarded to these disqualified persons at its sole discretion.
- ▶▶ The Prizes for Winners are: 1st Prize: \$2,000 cash
2nd Prize: \$1,000 cash
3rd Prize: \$500 cash
7 Merit Prizes: \$200 cash each.
- ▶▶ Photograph entries should be submitted on prints of 8R (8” X 10”) or Super 8R (8” X 12”) size without mounting. A copy of the completed entry form is to be pasted on the back of each photograph. Participants are also required to submit a digital copy (of at least 300dpi) of their photograph entry in a CD-ROM (Compact Disc).
- ▶▶ Participants may submit up to eight photograph entries. However each photograph entry must be accompanied by a duly completed entry form. Photocopies of the entry form are acceptable in this regard and can be downloaded from www.lta.gov.sg or collected at LTA HQ Blk 1 Lobby, at No. 1 Hampshire Road from Monday to Friday, between 9am and 5.30pm. All photographs shall be submitted at LTA HQ Blk 1 Lobby, at No. 1 Hampshire Road from Monday to Friday, between 9am and 5,30pm from 1 February 2010 to 15 March 2010.
- ▶▶ Each photograph entry must be based on the participant’s interpretation of the theme as follows:
The Circle Line: Connecting Me To Places I Want To Go
Photographs capturing the people, the experiences, the activities or the special moments shared in places that the Circle Line have brought you to. Contestants have to submit a description of the subject of their photographic pieces in 50 words or less; how the Circle Line enhances their commuting experience to their favourite destinations.
- ▶▶ Composite photographs and multiple exposures will be disqualified.
- ▶▶ LTA will not be responsible for lost or damaged photograph entries. All photograph entries shall not be returned to the participants.
- ▶▶ All photograph entries must be original creations. Participants warrant that they either own or have obtained the proper licences and/or permission to use all intellectual property applied in creating their photograph entries before submission to LTA. Participants are also to ensure that the licences and/or permission obtained extends to LTA, their agents and assigns for the purposes set out in these Terms. Notwithstanding, participants warrant that LTA, their agents and assigns’ use of the photograph entries will not infringe the intellectual property rights of any third party and agree to indemnify LTA, their agents and assigns against any claims of infringement.
- ▶▶ Participants agree that LTA, their agents and assigns are allowed an exclusive right to use, reproduce or adapt their photograph entries for the purposes of LTA Circle Line Photography Competition, exhibitions or in any publicity materials relating to the Competition LTA from 1 February 2010 to 31 December 2011. Participants acknowledge that upon submission of their photograph entries, LTA and their assigns may in their discretion, use the photograph entries or parts thereof for the said purposes without further reference to or acknowledgement of the participants for the said period. The participants shall not have the right to otherwise deal with the rights contained in the photograph entries unless prior written permission has been obtained from LTA, whose consent shall not be unreasonably withheld or delayed.
- ▶▶ If the photograph entries are found to be appropriate for use beyond the permitted use stated in these Terms, LTA shall negotiate with the relevant participant on the terms of their use separately. Unless otherwise stated in these Terms, LTA agrees that it will not use the photograph entries for any other forms unless written permission has been obtained from the relevant participant.
- ▶▶ A final judging panel appointed by LTA will select the winners, from the short-listed photograph entries selected by a pre-judging selection panel on the basis of the judging criteria. The judges’ decision is final and no correspondence will be entertained. LTA reserves the right to reject any application at its discretion.
- ▶▶ Short-listed participants will be notified by phone or email. The short-listed photograph entries will be exhibited by LTA as part of the Circle Line pre-/and opening ceremony publicity and activities.
- ▶▶ LTA has the discretion to change the prizes and their composition. Prizes not collected by the stipulated date will be donated to charity.
- ▶▶ By submitting your information in the entry form, you hereby agree and consent to LTA retaining and using all the data/information submitted by you in the application form for LTA’s stakeholders’ engagement efforts and publicity programmes and activities, and to the furnishing of such data/information to LTA, their agents or assigns for such purposes. You are required to provide all requested information accurately, failing which LTA shall have the right to disqualify your photograph entry. LTA may also use your information to contact you in the future for stakeholders’ engagement purposes. Your personal information may be disclosed to relevant authority and winners’ names published as required by LTA. A request to access, update or correct any information should be directed to LTA at the address set out above.
- ▶▶ These Terms shall be governed by the laws of Singapore. The participant hereby agrees to submit to the exclusive jurisdiction of the Singapore Courts.
