

Eligibility for the COVID-19 Driver Relief Fund (CDRF), CDRF Top-up (CDRF+), Extended CDRF (CDRF2), Enhancement to CDRF Extension (CDRF2+), Second Extension of CDRF (CDRF3) and Enhancement to the Second Extension of CDRF (CDRF3+)

CDRF, CDRF+, CDRF2, CDRF2+, CDRF3 and CDRF3+ criteria

- For CDRF:
 - (a) All existing drivers who have qualified for the SRF under any of the three tranches of Point-to-Point Support Package (PPSP, PPSP2 and PPSP3) respectively; or
 - (b) Active PHC drivers who have completed an average of 200 trips per month from 1 October 2020 to 31 December 2020 (inclusive).
- For CDRF+:
 - (a) All existing drivers who have qualified for the CDRF and currently receiving CDRF in respect of the month of May 2021.
- For CDRF2:
 - (a) All existing drivers who have qualified for the CDRF; or
 - (b) Active PHC drivers who have completed an average of 200 trips per month from 1 March 2021 to 31 May 2021 (inclusive).
- For CDRF2+:
 - (a) All existing drivers who have qualified for the CDRF and CDRF2.
- For CDRF3:
 - (a) All existing drivers who have qualified for CDRF2; or
 - (b) Active PHC drivers who have completed an average of 200 trips per month from 1 June 2021 to 31 August 2021 (inclusive).
- For CDRF3+:
 - (a) All existing drivers who have qualified for the CDRF3.
- **Facilitating PHC Operators**¹ will notify these drivers of their eligibility by 18 January 2021 for CDRF; 31 May 2021 for CDRF+; 9 July 2021 for CDRF2; 31 July 2021 for CDRF2+; 8 October 2021 for CDRF3 and 29 October 2021 for CDRF3+.
- The quantum for CDRF, CDRF+, CDRF2, CDRF2+, CDRF3 and CDRF3+ payments will be based on a per vehicle basis.
 - (a) In respect of the CDRF, each vehicle will receive no more than \$20/day for the first 90 days and no more than \$15/day for the last 90 days of the CDRF period from the Government.

- (b) In respect of the CDRF+, each vehicle will receive no more than \$10/day for the 46 days of the CDRF+ period from the Government.
- (c) In respect of the CDRF2, each vehicle will receive no more than \$10/day for the first 60 days and no more than \$5/day for the last 33 days of the CDRF2 period from the Government.
- (d) In respect of the CDRF2+, each vehicle will receive no more than \$10/day for the first 41 days and no more than \$5/day for the last 30 days of the CDRF2+ period from the Government.
- (e) In respect of the CDRF3, each vehicle will receive no more than the equivalent of \$10/day for the first 31 days and no more than \$5/day for the last 30 days of the CDRF3 period from the Government.
- (f) In respect of the CDRF3+, each vehicle will receive no more than the equivalent of \$5/day for the first 30 days and no more than \$5/day for the last 31 days of the CDRF3+ period from the government.
- Eligible PHC drivers who shared a vehicle with other eligible PHC drivers during the **Qualifying Period**² will have their CDRF, CDRF+, CDRF2, CDRF2+, CDRF3 and CDRF3+ payment apportioned equally with any other eligible PHC drivers sharing that vehicle³.
 - Eligible PHC drivers will have to continue maintaining an active driver account with their Facilitating PHC Operator, and possess a valid Taxi Driver's Vocational Licence or Private Hire Car Driver's Vocational Licence to receive the CDRF, CDRF+, CDRF2, CDRF2+, CDRF3 and CDRF3+ payment. Eligible PHC drivers whose Taxi Driver's Vocational Licence, Private Hire Car Driver's Vocational Licence or driver account with the Facilitating PHC Operator has been suspended or terminated will not receive the CDRF, CDRF+, CDRF2, CDRF2+, CDRF3 and CDRF3+ payment for the period of suspension or termination (as applicable).
 - To receive the CDRF, CDRF+, CDRF2, CDRF2+, CDRF3 and CDRF3+ payment for a relevant month during the **Disbursement Period**⁴, Eligible PHC drivers must complete at least one trip with their Facilitating PHC Operator in the preceding month.
 - Eligible Taxi or PHC drivers under any stay-home notice, isolation order, health risk warning, hospitalization leave or certified sick leave (each a "**work absence order**" and collectively, the "**work-absence orders**") shall only receive the CDRF, CDRF+,

CDRF2, CDRF2+ and CDRF3 (as applicable) if they do not receive full reimbursement or compensation for their vehicle rental as a result of any work absence order(s) issued to them.

- Eligible PHC drivers shall only nominate **ONE** Facilitating PHC operator to disburse the CDRF, CDRF+, CDRF2, CDRF2+, CDRF3 and CDRF3+ payment.

Criteria for CDRF+

- All existing eligible drivers who are currently receiving CDRF in respect of the month of May 2021.
- The CDRF+ will be disbursed per vehicle. Each vehicle will receive no more than \$460 in total for the period of 16 May 2021 to 30 June 2021. Eligible PHC drivers who shared a vehicle with other eligible PHC drivers during the **Qualifying Period**² will have their payment apportioned equally with any other eligible PHC drivers sharing that vehicle³.
- Eligible PHC drivers will have to continue maintaining an active driver account with their Facilitating PHC Operator, and possess a valid Taxi Driver's Vocational Licence or Private Hire Car Driver's Vocational Licence to receive CDRF+. Eligible PHC drivers whose Taxi Driver's Vocational Licence, Private Hire Car Driver's Vocational Licence or driver account with the Facilitating PHC Operator has been suspended or terminated will not receive CDRF+ for the period of suspension or termination (as applicable).
- No re-nomination of Facilitating PHC Operator is required, as the CDRF+ will be disbursed through Eligible PHC drivers' last CDRF-nominated PHC Operator by 31 May 2021.
- Taxi hirers will receive CDRF+ through daily rental rebates provided by their respective taxi operators.

[1] "Facilitating PHC Operators" refers to Comfort, Go-Jek, Grab, Ryde and TADA.

[2] "Qualifying Period" for CDRF and CDRF+ refers to 1 October to 31 October 2020, 1 November to 30 November 2020, and 1 December to 31 December 2020. In the case of existing drivers who have qualified for the SRF under any of the three tranches of Point-to-Point Support Package (PPSP, PPSP2 and PPSP3) respectively, "Qualifying Period" for CDRF and CDRF+ refers to the period which was used for the

assessment of the drivers' SRF eligibility. "Qualifying Period" for CDRF2 and CDRF2+ refers, in respect of existing drivers who had qualified for CDRF, to the period which was used for the assessment of the drivers' CDRF eligibility, and in respect of any other driver who is not an existing driver who had qualified for CDRF, refers to 1 March to 31 May 2021. "Qualifying Period" for CDRF3 and CDRF3+ refers, in respect of existing drivers who had qualified for CDRF2, to the period which was used for the assessment of the drivers' CDRF2 eligibility, and in respect of any other driver who is not an existing driver who had qualified for CDRF2, refers to 1 June to 30 June 2021, 1 July to 31 July 2021, and 1 August to 31 August 2021.

[3] Eligible PHC drivers who previously received a portion of the SRF or CDRF (due to the sharing of vehicles with other drivers) shall have their CDRF, CDRF+, CDRF2, CDRF2+, CDRF3 and CDRF3+ (as applicable) apportioned in a similar manner.

[4] "Disbursement Period" for CDRF for PHCs refers to 18 January 2021 to 16 July 2021 (inclusive).

"Disbursement Period" for CDRF+ for PHCs refers to 16 May to 30 June 2021 (inclusive).

"Disbursement Period" for CDRF2 for PHCs refers to 17 July 2021 to 17 October 2021 (inclusive).

"Disbursement Period" for CDRF2+ for PHCs refers to 22 July 2021 to 30 September 2021 (inclusive).

"Disbursement Period" for CDRF3 for PHCs refers to 1 October 2021 to 17 December 2021 (inclusive).

"Disbursement Period" for CDRF3+ for PHCs refers to 1 November 2021 to 30 November 2021 (inclusive) and 18 December 2021 to 17 January 2022 (inclusive).
