

## **EV Charger Registration Process**

### **For existing chargers installed before 8 December 2023**

#### **Step 1: Submit an application**

To submit an application for registration, the owner of an existing EV charger (i.e. an EV charger that has been installed pre-EVCA commencement) should provide the following details via <https://go.gov.sg/existing-ev-charger>:

- Manufacturer of EV charger
- Model name/type reference of EV charger
- Date of installation of EV charger
- Proof of purchase (e.g. receipt or delivery invoice)
- Particulars of applicant (e.g. name, NRIC/FIN/UEN, contact number, email address)
- Number of EV charger(s) to be registered
- Photos of each EV charger(s) (which should show the manufacturer name plate of the EV charger)

LTA will check the application to verify whether the EV charger had been issued with a Letter of No Objection (LNO)<sup>5</sup> and will inform the applicant of the outcome within 30 days, via email.

#### **Step 2: Outcome of verification**

Once the EV charger has been successfully verified, LTA will issue a provisional ID via e-letter in the applicant's OneMotoring inbox for the applicant to proceed to register the EV charger. If the EV charger is not successfully verified, the applicant will be required to replace the EV charger for safety reasons, by 7 June 2024.

#### **Step 3: Charger Registration**

For EV chargers that have been verified, the applicant can proceed to register the EV charger using the provisional ID (issued under Step 2) via the OneMotoring website.

#### **Step 4: Registration Mark**

Upon successful registration, LTA will issue a confirmation letter and the EV charger registration mark to be affixed onto the EV charger by mail. The registration mark must be affixed onto the EV charger in a clear and visible manner within 60 days from the date of registration.

### **For new chargers installed on or after 8 December 2023**

Applicants can proceed to register the EV charger using the type approval ID found on the approval label affixed on the charger via the OneMotoring website.

If the EV charger does not have an approval label affixed, you may:

- Contact the supplier of your EV charger to request for an approval label; or
- Submit a request for a provisional ID at <https://go.gov.sg/new-ev-charger> . LTA will require you to provide details of your charger to verify whether the EV charger had been issued with a Letter of No Objection (LNO) and will inform you of the outcome within 30 days. For EV chargers that are successfully verified, LTA will issue a provisional ID for the applicant to proceed to register the EV charger via the OneMotoring website.

Upon successful registration, LTA will issue a confirmation letter and the EV charger registration mark to be affixed onto the EV charger by mail. The registration mark must be affixed onto the EV charger in a clear and visible manner within 60 days from the date of registration.
