- 2. The 13km East Coast stretch of the TEL (TEL 4 & 5) will connect commuters living in the eastern parts of Singapore to the heart of the city. This East Coast stretch will have nine stations, including one interchange station with DTL3e and a 4-in-1 Rail and Bus Depot.
- 3. The proposed EWL Upgrade consists of modification works at the existing EWL Tanah Merah Station (EW4) to have an additional platform, a new extended concourse area with subways leading to new entrances and an extended viaduct connection to the 4-in-1 Rail and Bus Depot.
- 4. CCL6 is the proposed extension of Circle Line, connecting HarbourFront Station (CC29) and Marina Bay Station (CE2) with 3 underground stations, and an extension of the existing Kim Chuan Depot (KCD) to provide additional train stabling spaces and maintenance.
- 5. Interested applicants are required to submit past and current records of similar projects undertaken. Applicants must demonstrate that they have the necessary:
 - (a) Technical expertise and project management capability in the supply, installation, testing and commissioning, and maintenance of lifts and escalators for underground RTS; and
 - (b) Financial capacity to undertake and sustain a multi-million dollar project in Singapore.
