- 4. The proposed TSL will be fully underground with a route length of approximately 30km and 22 stations (6 interchanges), and an at-grade depot. It will run along a North-South direction serving housing estates such as Woodlands, Ang Mo Kio, Thomson and Sin Ming area before running into the city and Marina Bay area.
- 5. At the discretion of the Land Transport Authority (LTA), the tenders for Contract T253 may include options for additional works that are an extension of TSL.
- 6. Interested applicants are required to submit past and current records of similar projects undertaken. Applicants must demonstrate that they have the necessary:
 - (a) Technical expertise and project management capability in the supply, installation, testing and commissioning of High Voltage (HV) Power Supply System and DC Traction System for MRT; and
 - (b) Financial capacity to undertake and sustain a multi-million dollar project in Singapore.

Applicants should not rely on their current standing and reputation but should provide all information as requested in the brochure.
